

The factory purchases the raw materials and parts from a range of locations across Europe. The transport from suppliers to the Bulgarian factory has been accounted for in A2 and the transport to the Optimera stores in A4.





The end of life reflects the Nordic market, where 75% of mixed waste is landfilled, 7% incinerated with energy recovery and 17% recycled. For the credit for recovered electricity and heat (module D), EU datasets were used.

Generic database data was used for the production of raw materials, energy, transportation, packaging and end-of-life. Specific data was collected from the factory.

#### Time representativeness

The site-specific data used for the product manufacturing corresponds to 2021. The age of data from generic databases varies from 2013 – 2021.

#### Data quality

All datasets used came from reputable databases GaBi and Ecoinvent, with good technological representativeness and which represent either Sweden or EU28 average. Therefore, it could be considered good.
